Appreciating our Diverse Pasts

Comprehending our Complex Presents

Prefiguring our Possible Futures

Like so many initiatives and approaches which emerged during the sixties and seventies, Participatory Action Research (PAR), Action Research (AR) and Action Learning (AL) have come of age. As the previous seven ALARPM/ALARA Congresses are testimonies to, several generations of practitioners have added their hearts, hands and minds to earlier traditions. Their work has been differentiated into 'applied fields'; journals and second and third editions of 'handbooks' have been published. The underlying philosophy and 'ways of knowing', methodologies and methods have become 'standard' fare in reference lists, workshops and course syllabi, leadership manuals, organisational protocols. These are all signs of a mature and meanwhile global discourse.

As several of the initiators of the PAR, AR and AL 'traditions' are now reaching their 'third age', now is an auspicious time to critically but appreciatively assess our present practices and understandings and to dream possible futures (page 3). Indeed, as exemplified by the many 'words' filling the front page of this program and the 'streams' of praxis we are using to assist in orchestrating our conversations (page 6), the proliferation of PAR, AR and AL across many institutional, professional and programmatic fields requires us to reflect on our commonalities, our foundational principles whilst fully staying in touch with the diversity of our praxis. Finally, we have chosen four 'Themes' to guide our conversations across times and streams and to help us maintain a degree of coherence (pages 3,4).

Congress Program: the overall flow of conversations

DAY 1: The origins of AL, AR and PAR: Whose shoulders are we standing on?

What are our legacies, sources, historical, philosophical, practical, areas of application? Day One offers opportunities to converse about and better appreciate the foundations of the various participatory and action-based approaches to learning, researching, social change, organisational change, community and international development, welfare and health, the ecology, working with certain groups of people. What can we learn from the elders in our various movements? How can we maintain and emulate the spirit of those who were then brave enough to try and make a difference, with such vigour and effect?

DAYS 2 & 3: Our present(-s): Where are we today with AL, AR, PAR?

Days Two and Three will explore the status of present-day praxis and will offer manifold opportunities to better understand and reflect on the complexities and challenges of today's practitioners' stories in the supportive company of others active in their fields of practice.

Day Three - more particularly - will offer an opportunity to meet in stream-specific venues across Melbourne. The venues are 'home' to institutions, organisations or agencies active in your particular applied field of PAR, AR, AL. The meetings will be co-organised by local groups and networks active in these fields and will (possibly) consist of keynote, plenary and workshop presentations, demonstrations, posters, whatever seems relevant and expressive of the particular directions PAR, AR and AL take in these field(s). More information about the modalities of the 'streams' can be found below. This day will provide a great opportunity to learn and reciprocally develop our skills!

DAY 4: Prefiguring: How will we evolve PAR, AL and AR in the times we inhabit?

We will explore questions of the next steps we will (have to?) take in the environments we co-create whilst engaging in our PAR, AR, AL work in our various working contexts. How will we address our local-global predicaments? How can we nurture up-and-coming generations of present and new practitioners and researchers whilst also staying in conversation with 'older' and second and third generations? How will we further develop the various approaches participants have shared during the previous three days and take them into our own habitats?

Key Themes of the World Congress

In addition to and in support of the reflective '*genealogical*' look at our philosophical foundations and an appreciative look at present and future practices in their real-life contexts, we propose the following *four themes* as conceptual guides for delegates who intend to present at the Congress and for all participants to start contemplating their choices of workshops. They may also serve to create a degree of coherence across time and fields of practice. Each theme will be introduced by an internationally renowned key note speaker.

Theme 1. *Philosophical Foundations*

This theme will guide the exploration of the philosophical foundations of action-based, social change oriented and participatory approaches to research and learning: is there a common and united philosophical basis across the various applied fields? Are variety and hybridity necessary characteristics of the work we do in its several rather distinctive practical and organisational contexts? What have been the (latest) developments in the philosophical underpinnings of our approaches? Ontology, epistemology, the value-base in which we ground our knowledge and the recognition of the spiritual and relational dimension of our work: how can we reflectively and practically deepen and extend our understanding of the influence of these on our practice? How do other-than-western world epistemologies and trans- and cross-cultural relationships influence our practice?

Keynote Speaker: Dr. Alan Rayner

Alan Rayner is a naturalist who uses art, poetry and a new form of mathematics, as well as rigorous science to enquire and communicate about our natural human neighbourhood. He has published over 150 scientific articles, 6 formal scientific books (including *Degrees of Freedom: Living in Dynamic Boundaries*) and six e-books. He was President of the British Mycological Society in 1998 and has been a Miller Visiting Research Professor at the University of California, Berkeley. He has been using a participatory and co-creative approach to introduce and develop his evolutionary understanding of *natural inclusion* since 2001.

Congress Paper: *Sustainability of the Fitting – bringing the philosophical principles of natural inclusion into the educational enrichment of our human neighbourhood*

Theme 2. *Power*

Power and its uses, misuses and abuses in the learning and research relationship has over time been receiving waxing and waning degrees of attention, even if the 'action' and 'participatory' references would suggest a greater centrality in our work. How is the theme of power, latently or openly relevant in our practical work and how does it manifest in our working relationships? Some authors now suggest the re-emergence of 'class' in industrialised societies and many see the persistence of other divisions in societies along gender-, race-, ability-, state of 'development' and other lines; how may we take account of this reality in our approaches to AL, AR and PAR? How does participatory practice link up with our democratic ideals? How do the politics of resource allocation, of money and of bureaucracies – state, NGO and corporate – influence our work... for better or worse?

Keynote Speaker: Professor Budd Hall

Budd Hall is the Director of the Office of Community-based Research at the University of Victoria in British Columbia Canada. He is also the Secretary of Community-based Research Canada and the Global Alliance for Community Engaged Research. He may be considered an Elder in the field of action research having pioneered work in Tanzania in the early 1970s, later founding the International Participatory Research Network. He served as Secretary-General of the International Council for Adult Education for 11 years where he worked with Paulo Freire. Budd participated in the 1976 Cartagena Conference organized by the late Orlando Fals Borda as well as the ALARA event in the same city in 1996. His research and writing are in areas of participatory research, social movement learning, community-university research partnerships and the role of poetry in social change.

Congress Paper: *Whose Local? Whose Global? Knowledge, Power and Privilege in a Troubled World*

Theme 3. *Methodology*

The perennial issues of methodology will remain central to our deliberations; how relevant are questions about quantitative and qualitative approaches, their associated techniques and methods within the context of AR and PAR? What is the nature of the research / learning / consulting relationship in AL, AR and PAR? How do we evolve an appropriate process in terms of overall timing, ethics agreements, agreements about steps? What issues surround our use of language, our metaphors, especially in contexts characterised by deep divisions as mentioned above? What are we to do with the results of our work? How can we negotiate ownership of outcomes and the paradoxes between the commercial and political/personal dimensions of our practice?

Keynote Speaker: Professor Linda Tuhiwai Smith

Linda Tuhiwai Smith is Professor of Education and Māori Development and Pro-Vice Chancellor Māori at the University of Waikato. She has worked in the field of Māori education for many years as an educator and researcher and is well known for her work in Kaupapa Māori research. Professor Smith has published widely in journals and books. Her book *“Decolonising Methodologies: Research and Indigenous Peoples”* has been an international bestseller in the Indigenous world since its publication in 1998. More recently Professor Smith was a Joint Director of Ngā Pae o Te Maramatanga, New Zealand’s Māori Centre of Research Excellence and a Professor of Education at the University of Auckland. She is well known internationally as a public speaker. Professor Smith is from two iwi in New Zealand, Ngāti Awa and Ngāti Porou.

Theme 4. *Practice/praxis*

Practice/praxis issues and stories about concrete experiences and examples of our ongoing work should remain central considerations. What are the pragmatics of process in participants’ AL, AR, PAR work? What stories, ‘living theories’ and novel/innovative moments can we share for further consideration? What are present contradictions-in-practice and how do we deal with them—also ethically? Many projects continuously touch upon issues of politics and policy; how are the connections being made, what are the emerging issues and the energetic new theories?

Keynote Speaker: Yoland Wadsworth

Yoland Wadsworth has been involved in PAR since the early 1970s and has written Australia's two bestselling social research and evaluation books based on a PAR approach. The final in the trilogy *“Building in Research and Evaluation for Living Human Systems”* is to be published in 2010. She is an Adjunct Professor at RMIT University and Principal Fellow at the University of Melbourne and has worked for 38 years with NGOs, government and community organisations, primarily in health and human services. Yoland is a life member and former president of ALARA, founder in 1986 of the Action Research Issues Association (ARIA) and its current convener.

Congress Paper: *Action Research for life - an integral epistemology for (truly) living systems.*

Participatory Action Research

Over the last fifteen years ALARPM (now) ALARA World Congresses have taken place in a partnership with the world's participatory action research communities. This network has at times been held by specific institutions, such as Cornell University, and at others as loose gatherings of individuals. For this World Congress, ALARA, Borderlands Cooperative are proud to announce that the People, Power and Social Change Team at the Institute for Development Studies, UK <http://www.ids.ac.uk/go/research-teams/participation-team>, are sponsoring the participatory action research partnership with ALARA.

Streams of Praxis

Assuring that our conversations remain anchored in real-life contexts and reflect the existing potentials as well as barriers in our fields of practice, workshops, formal paper and catalytic paper presentations and discussions as well as the poster sessions (see below) will be organised in designated '*streams of praxis*'. We hope that our denomination and delineation of the various selected fields-of-engagement strike a chord with participants.

Day two and three of the Congress are more specifically dedicated to examining and reflecting on contemporary PAR, AR and AL praxis across the several streams. '*Stream coordinating groups*' with a designated Chairperson will connect with the international networks operating in the respective fields to assist in organising a program for the third day and in their specific stream, including assisting in organising an appropriate venue. Everyone is invited to contribute to the conceptual development of the 'streams' via www.alara.net.au." In subsequent announcements also at the ALARA website, participants and presenters will be kept informed of the final 'shape' the 'streams of praxis' will adopt during Congress proceedings.

The streams are listed below together with an indication as to the aspects which may become topical in their 'conversations' at the Congress.

(Social) Ecology and its several areas of engagement, including social and deep-ecological approaches and projects; agriculture and sustainability; landcare, environment, wilderness and conservation; ecology-community-economy; the social ecology of (dis)ability and ageing and their (dis)contents. **Chair:** Dr Christine King, School of Integrative Systems, University of Queensland

International Development and its various aspects and levels of involvement, including community development and cooperation, fair trade, volunteering and technical assistance, aid, solidarity and awareness projects, alternative development 'models' and practices.

Co-Chairs: Dr Rob Nabben, Deakin University and Daniel Salinger, Regional Director for Latin America, International Institute of Rural reconstruction.

Health and Wellbeing (including the various 'welfare' fields of engagement); work and involvement across the curative/preventative/self help spectrums; health, individuals and social contexts; health and environment; health and work; welfare institutional contexts and PAR, AR and AL: political, economics and pragmatics.

Chair: Dr Ian Hughes, Honorary Senior Lecturer, University of Sydney.

Systems / Business / Organisational Development; this stream will include the members of *Australia New Zealand Systems* (ANZsys), a regional network of AR and AL practitioners interested in 'whole systems' approaches and who will use the Congress as their 'annual conference', therewith opening up their experiences to everyone and ready to learn—in turn—from everyone.

Chair: Dr Danny Burns, Director, SOLAR Centre, Univ. of West England

Education and Learning, from pre-school to post-graduate; one of the historical entry-points for AR, AL and PAR; 'living theory' approaches to (P)AR/AL; narrative and deconstructionist influences on education and AR and AL; new fields opening up: life-long learning, technical education, university of the third age, pre-school and parent groups.

Chair: Dr Jack Whitehead, Professor at Liverpool Hope University

Decolonising praxis, including cross-cultural learning with Indigenous and other Peoples and contexts; epistemological and ontological challenges to positivist and post-positivist approaches to PAR, AR and AL; are we post-colonial yet? Reflecting on and reframing the research and learning *relationships* and learning from insider voices; empire, research and learning: how far have we come?

Co-Chairs: Dr. Karen Adams, Research Fellow, Australian Community Centre for Diabetes, Victoria University and Dr. Bronwyn Fredericks, Senior Research Fellow, Faculty of Health, Queensland University of Technology (QUT).

The ALARA website - www.alara.net.au/worldcongress/2010/objectives - will be regularly updated as to developments in the AR, AL and PAR streams and the more general thematic developments as they come to hand. We encourage everyone interested in becoming involved in a stream to contact the Organising Committee and/or communicate via the ALARA website as indicated above.

Call for Abstracts and Proposals

Abstracts for Paper or Catalyst Presentations, Workshop proposals, proposals for Poster Sessions and discussion-rounds are invited; the Organising Committee will receive abstracts for proposed refereed contributions (up to 300-400 words) from interested individuals and groups till **May 31st 2010**. The proposals will be reviewed by the ALARA World Congress Editorial review Panel, who will also offer some feedback as to the linkages of the proposed presentations or discussions with the themes of the Congress.

As is congruent with the participatory intentions of the Congress, we would like to minimise one-way lecturing communication. We particularly encourage innovative and creative presentations designed to stimulate interaction, reflection and dialogue among those attending sessions.

Types of sessions being planned at the Congress

(most sessions will be of 1 ½ hours duration; see program structure on the next page):

Workshop: 1 or 2 sessions in 1 ½ hours, depending on proposed theme and process. Focusing on and engaging with praxis / practice-theory / strategy / experiential approach. Approaches may include drama, visual media, arts, group work, discussion, round-table discussions, panels. Supported by a facilitator/moderator.

Catalytic paper: 25 minutes per presentation (3 in 1 ½ hours). A strongly and pointedly argued one-page statement, to be briefly introduced by its author and followed by a 20 minutes facilitated discussion. Focus on a theme/issue of historical / theoretical / methodical / philosophical / praxis importance. Participatory process supported by a moderator/facilitator.

Standard paper: 25 minutes per presentation (3 in 1 ½ hours). The substance of the paper to be summarised / presented by the author(s) in 15 minutes, leaving 10 minutes for responses, discussion and expansion. Supported by a moderator/facilitator and conducted in as participatory a process as possible.

Poster session: pin boards and/or trestle tables will be made available in the reception and lunch area of the Congress venue. Set up during morning proceedings, the presenter would be available during the lunch break to interact with interested Congress participants. The presenter may choose either 1 or 2 sessions for the duration of the Congress.

Intending participants will be notified about the acceptance of their proposals by **July 1st 2010**. Those who need earlier confirmation about the acceptance or otherwise of their proposal should indicate this in an accompanying email/letter and we will do our very best to speed up the refereeing process as necessary.

A selection of presented papers will be published in an ALARA publication after the Congress. A special ALARA editorial review panel will be set up for that purpose and more details about the requirements and formalities of intended contributions will be provided shortly.
